- PLAYER OPTION
- NON-GUARANTEED IN LATER YRS
- LIKELY INC. RELATED TO OFFENSIVE EFFICIENCY

PROS & CONS

PROS OF SIGNING NOW

- Great bargain if his offensive efficiency stays around the level of his platform season
- Avoid competitive free agent market and unfavorable offer sheets (control the structure)
- Get ahead of potentially pricier market following new TV deal
- Can sign long term contract that should age well (new CBA rules allow 5 year extensions that are non max)

CONS OF SIGNING NOW

- Run the very real risk that he cannot maintain his current level of offensive efficiency
- Forecloses many options for improving the Magic's struggling offense
- Pushes team to close to the tax, essentially committing Suggs to part of the core
- Commits to financial inflexibility down the road (depending on deal size)
